

# **Basketball Ireland Safeguarding Guidelines for Videoing and Photography Permissions**

## In Compliance with Irish Sporting Guidelines and GDPR Regulations

Basketball Ireland is committed to ensuring the safety, privacy, and dignity of all players, particularly minors, when videoing or photographing at our events. These guidelines align with Sport Ireland's Child Safeguarding Policies, the General Data Protection Regulation (GDPR), and Basketball Ireland's Safeguarding and Data Protection Policies.

# 1. General Principles

- The welfare and protection of children is paramount.
- All photography and videography must be appropriate, respectful, and used solely for its intended purpose.
- Consent must be **explicit**, **informed**, **and documented**, particularly when involving minors.
- Personal data protection obligations under GDPR must be followed when handling and storing images/videos.

## 2. Safeguards for Photography and Videoing at Basketball Ireland Events

## 2.1 Consent Requirements

✓ Written consent must be obtained from a parent or guardian before photographing or filming minors.

✓ Consent forms must specify:

- The purpose of the media (e.g., promotion, coaching, social media).
- Where the images/videos will be published (e.g., Basketball Ireland website, club social media).
  - ✓ Individuals aged **16 or older** (per GDPR regulations) may provide their own consent.
  - ✓ Parents and participants must be able to **withdraw consent at any time**, and the media must be deleted accordingly.

# 2.2 Appropriate Content Guidelines

✓ All images/videos must be:

- Relevant to basketball activities (e.g., action shots, team photos).
- Respectful and age-appropriate (no compromising positions or private moments).
- Non-identifiable where possible (avoid personal details in captions or images).



# X Never capture images of:

- Players in changing rooms, bathrooms, or private spaces.
- Minors in revealing, suggestive, or inappropriate attire.
- Children who have opted out of media consent.

## 2.3 Restrictions on Sharing and Publication

- ✓ Photographs/videos should only be used for the **intended purpose** (e.g., coaching, promotional content).
- ✓ Images should not contain **full names or personal details** of minors.
- ✓ Secure platforms must be used for **storage and sharing** (e.g., club websites, official Basketball Ireland channels).
- ✓ Personal social media accounts should **not** be used to share images of minors.

#### X Never:

- Tag a minor in social media posts.
- Share images in WhatsApp groups or unencrypted communication platforms.
- Edit or manipulate images in a way that alters the context or misrepresents individuals.

# 2.4 Filming for Coaching and Performance Analysis

- ✓ Coaches may video players for training purposes with **prior consent** from parents and the club.
- ✓ Videos should be stored securely and **deleted when no longer needed**.
- ✓ Players should be made aware when being recorded, and the footage should be **used solely for training purposes**.

#### X Do not:

- Share footage outside of the coaching team.
- Publish private training footage on public platforms.

## 2.5 Third-Party Photographers and Media

- ✓ Professional photographers must be **approved** by Basketball Ireland and wear **visible accreditation**.
- ✓ All media personnel must sign a **Code of Conduct** and adhere to **child safeguarding guidelines**.
- ✓ Where possible, an official **designated photographer** should be used for events to control image distribution.
- **X** Unregistered photographers or spectators should not be allowed unrestricted access to photographing children.



## 3. Security and Retention of Images and Videos

- ✓ All images/videos must be **securely stored**, with **restricted access**.
- ✓ Personal data must not be retained longer than necessary (in line with GDPR principles).
- ✓ Clubs should review and delete outdated images/videos annually.
- X Do not store images/videos on personal devices (use club-secured platforms instead).

## 4. Reporting Concerns and Breaches

- ✓ Any concerns regarding unauthorized or inappropriate use of images should be reported immediately to:
  - The club's **Designated Liaison Person (DLP)**.
  - Basketball Ireland's Child Protection Officer.
    - ✓ If an image is found to be **misused**, Basketball Ireland reserves the right to take **immediate action**, including:
  - Requesting removal from public platforms.
  - Reporting violations to the relevant authorities.

# 5. Compliance and Review

✓ This policy will be **reviewed annually** to ensure it aligns with evolving **GDPR regulations and safeguarding policies**.

✓ Basketball Ireland clubs and affiliates must **regularly educate staff, coaches, and volunteers** on these guidelines.

#### Conclusion

These safeguards aim to ensure that all photography and videography within Basketball Ireland is conducted in a way that **protects player privacy, upholds child safeguarding principles, and complies with data protection regulations**.
