Before we can invite you to apply for a Garda e-Vetting Form, it is a Garda Vetting requirement that you complete a 100 Point Identification Check. This form must be signed by a responsible person (Step 4) and forwarded along with photocopies of your ID to the authorised Liaison Person in Basketball Ireland once completed. Simply complete this form by following the steps below and an invitation to the e-vetting website will be sent to you on the email address provided in Step 1.
